



## Invitation for Online Bids

The Gurbhakot Municipality, office of the Municipal Executive surkhet has allocated funds towards the cost of Road construction Project and intends to apply part of the funds to cover eligible payments under the Contract for the Construction of Road Project as specified in the "The works" below. Bidding is open to all eligible Nepalese Bidders.
2. The Gurbhakot Municipality, office of the Municipal Executive surkhet electronic bids from eligible bidders for the construction and completion of Road Projects mentioned in the "The works" under National Competitive Bidding procedures.
3. In Case of Contract no NCB/WORKS/GM/01/2078-79 and NCB/WORKS/GM/02/2078-79 Only eligible bidders with the following key qualifications should participate in this bidding:
  - Minimum Work experience of similar Quantity, size and nature compulsory.

7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 hours on 2078/07/12 at the office of Gurbhakot Municipality, Surkhet. Bids must be valid for a period of 120 days after bid opening and must be scanned copy of the bid security in pdf format. amounting to a minimum as mentioned in The works" below, which shall be valid for 30 days beyond the validity period of the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
